## WHAT IS ARTENA NETWORK?


The Artena network is the solution to preventing users from being scammed in chat rooms in the crypto market. On the Artena chat platform, users will not be able to send private messages to each other, which will prevent phishing links. We will create an environment where users will only be able to chat with each other in the chat rooms of the projects, and only official groups of the projects will be available. The project team will automatically close fake chat rooms upon notification; everything is designed to allow users to access official resources.



## THE PATH FROM YOUR EXHANGE TO SECURE MESSAGING

Users of the "X" exchange can join the group of the approved project directly without reaching fraudulent groups


The Artena team cares about the satisfaction of users on the exchange, so once Artena Chat is complete and live, the team will be in talks with exchanges to partner with them.






# GROUP'S

By clicking on the group icon, when a country communities group is set up outside the global group, users from different countries will be redirected to the official approved country groups, not to fake groups created on your behalf.




The fake group will be banned from the app by Artena Network, which will defend the rights of the official group. when members of the closed fake group log in to the group, they will see the link to log in to the official group



## DATA TRAFFIC

-The basic principle of our purpose is to benefit crypto exchanges equally with our activities. Since traders spend most of their time outside of trading in information groups, this cooperation will be a mutually beneficial system. Let's assume that the bar on the left is the exchanges' weekday traffic data, while the purple part is generated by Artena Network. In order to enter the correct and official groups in our "Artena Chat" application, users will have to constantly use the exchange's control panel. Not only the official group of our project, but all coins listed on all partnering exchanges will be able to use our services, thus increasing the hours of use of the exchanges, people will increase and use the exchange data more instead of hanging out on different chat platforms, thus generating more data traffic.

INCREASE IN THE NUMBER OF USERS

Once our app is integrated with exchanges through partnerships, people who want to access our app will use the exchanges they are interested in, which can mean an environment where new potential customers will increase, our goal is to support exchanges and customers in a secure way under the umbrella of the blockchain industry.

#### WIN WITH KYC

Yes, you heard that right. We want our strategic partners to profit from KYC. We see usernames and pictures being copied all the time in different chat apps, and the Artena team wants to protect customers who are subject to KYC on exchanges, for example someone who wants to pretend to be a representative of your exchange and copies their personal pictures. There will be no private messages in the Artena system anyway, but we will make sure that profile pictures are personalized like "NFT". Artena GPT KYC will constantly scan the system for your clients and notify your client when a similar picture matches. If your client complains, the person who copied the profile picture will be banned from the system. But this will be a premium feature, for example "X" dollars per month. If your KYC client will pay "X" dollars to the system, about 33% of it, "X" dollars, will be paid to our partner, the exchange, and the rest will go to the Artena team and to cover the system requirements. this way we plan to both earn together with our partners and protect our partners' members.




#### **MAXIMUM EFFICIENCY**

ARTENA GPT will be developed and integrated into the application by our team. In addition to carrying out the system security of the application, it will provide convenience in many areas by allowing users to produce their own content, find answers to their questions, and respond to technical questions asked about the project within token groups. it is a premium product of our ecosystem and will be integrated into our system as a paid and free version.

customers will be able to contact live support directly from within the group to submit their complaints to the exchange's support department.




#### **VERIFIED GROUP**

## CUSTOMER SERVICE

For faster customer satisfaction, our partner exchanges and token projects can provide their clients with live support with Artena bot through the application, for this the support manager needs to type the /support command in the chat panel, quoting the user's text. then, when the user clicks on the link, a support room will open for him. After the client confirms the commitments he/she needs to know (the image is representative, any conditions can be imposed in the exchange), he/she can quickly specify his/her problems for support.



#### ARTENA SOCIAL

In addition to messaging and getting information in groups, we will also activate the social media section in the application. Projects can create a social media area for themselves here, inform their organic followers without bots in the application, and the content shared in the social media section will be automatically directed to the chat group.



ARTENA NETWORK is an idea developed against misleading redirects found in now traditional web2 programs.

As Artena team, we will adopt the web3 vision and launch an application called "ARTENA CHAT" to protect cryptocurrency investors who have adopted blockchain technology from misleading and fake link addresses.

In most chat applications, scammers target users' wallets by sending fake phishing links. As the ARTENA team, we want to create an environment where crypto traders can safely chat about the tokens they have purchased.

Let's talk about how our app module works;

- There will be no private chat on our platform.
- Users will only be able to actively chat in the projects' chat group.
- To protect our platform from scammers, "only project owners will have a yellow checkmark."
- People designated as moderators by the project owners in the group will have a blue checkmark.
- No one other than moderators will be able to post links to the groups.
- In order to support users, only administrators with yellow and blue checkmarks will be able to send messages, and sending messages is entirely at the discretion of the administrators. Administrators can announce the solution only in the general group if they wish.
- -Thanks to ArtenaGPT security, people who receive a verification tag can easily reach the managers of other projects and develop partnerships between projects.

- Except for the channels reported by the official project team "malicious spam pages will be closed upon complaint" only the channels allowed by the project team will be active.
- Yellow and blue checkmarks will not be automatically given to admins for each group opened, they will be given after verification by the project team "ARTENA" team.
- Normal group members will not receive any checkmarks, only the verified team will be eligible.
- After the release of our platform, negotiations will be held with exchanges to integrate it as a new chat window, information will be given on the subject and partnership will be tried to be provided.
- After the stock exchange integration is realized, if the profile picture and name of the traders who make KYC to the stock exchange are copied, the person who does not comply with the rules will be banned from the application in case of complaint and detection.
- -- When the administrator is not active in the group, people who behave inappropriately can be blocked thanks to the fast "DAO". For this, it is enough for 20 people to quote the message and execute the (-) command. The user will be muted and marked as an inappropriate person in the admin panel. Removal from the group is at the discretion of the administrators.
- The projects will have an artificial intelligence bot that provides information about themselves to their groups and transfers all the information they share on social media to the chat group as information to investors.
- ArtenaGPT will work on fraud detection by constantly renewing the system update.
- You will be able to produce content with ArtenaGPT.
